- 1. MOTION TO APPROVE ELECTION WORKERS PAY RELATED TO THE REGULAR NOVEMBER 7, 2023 ELECTION, THE (SINGLE) CHAIRPERSON'S RATE IS \$18/HOUR WHILE THE INSPECTOR'S RATE IS \$15/HOUR FOR THE (4-6) WORKERS.
- 2. MOTION TO ESTABLISH THE CITY'S ANNUAL HALLOWEEN 'TRICK-OR-TREATING' HOURS FROM 5:30P 7:30P.
- 3. MOTION TO APPROVE RESEARCHING SOCIAL ZONES TO ASSESS IF THERE IS A WANT/NEED, OR PURSUANT TO SUGGESTIONS BY LOCAL VENDORS, AND THE DELINEATED RESEARCH AND DISCUSSION MAY ENTAIL COMMUNICATIONS WITH THE STATE OF MICHIGAN, LIQOUR CONTROL COMMISSION, AND/OR FEEDBACK FROM A COUPLE OF THE EIGHTY-FIVE COMMUNITIES ALREADY ENGAGED IN ESTABLISHING SOCIAL ZONES.
- 4. MOTION TO APPROVE STUMP GRINDING BID BY JOE'S TREE SERVICE FOR THE REMOVAL/GRINDING OF SIXTY-NINE STUMPS AT MAPLE GROVE CAMPGROUNDS AND THE CEMETERY FOR A TOTAL OF \$3,500.00, FOR BOTH LOCATIONS, AND THE CITY WILL BE RESPONSIBLE FOR THE RELATED CLEANUP.
- 5. MOTION TO APPROVE A ONE-TIME BS&A SOFTWARE, LLC. CHANGE REQUEST, WHICH WILL BE \$2,000.00 TO ADD BADGER/BEACON WATER METER INTEGRATION.

MOTION TO APPROVE THE ENSUING DELINQUENT BALANCES, WHICH WILL BE SENT TO THE RESPECTIVE TOWNSHIPS FOR THEM TO APPROVE FOR INCLUSION ON THE 2023 TAX ROLL; THUS, THE EXACT RATES TO BE APPROVED ARE AS FOLLOWS, CALDWELL TOWNSHIP'S DELINQUENT SEWER USAGE FOR 2023 IS \$8,222.70 AND LAKE TOWNSHIP'S DELINQUENT SEWER USAGE FOR 2023 IS \$1,754.49, AND IN TOTAL THE DELINEATED CHARGES ARE \$9,977.19.
