complied with;

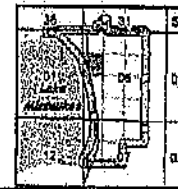
**NOW THEREFORE, BE IT RESOLVED** by the Lake City Council, at a Regular

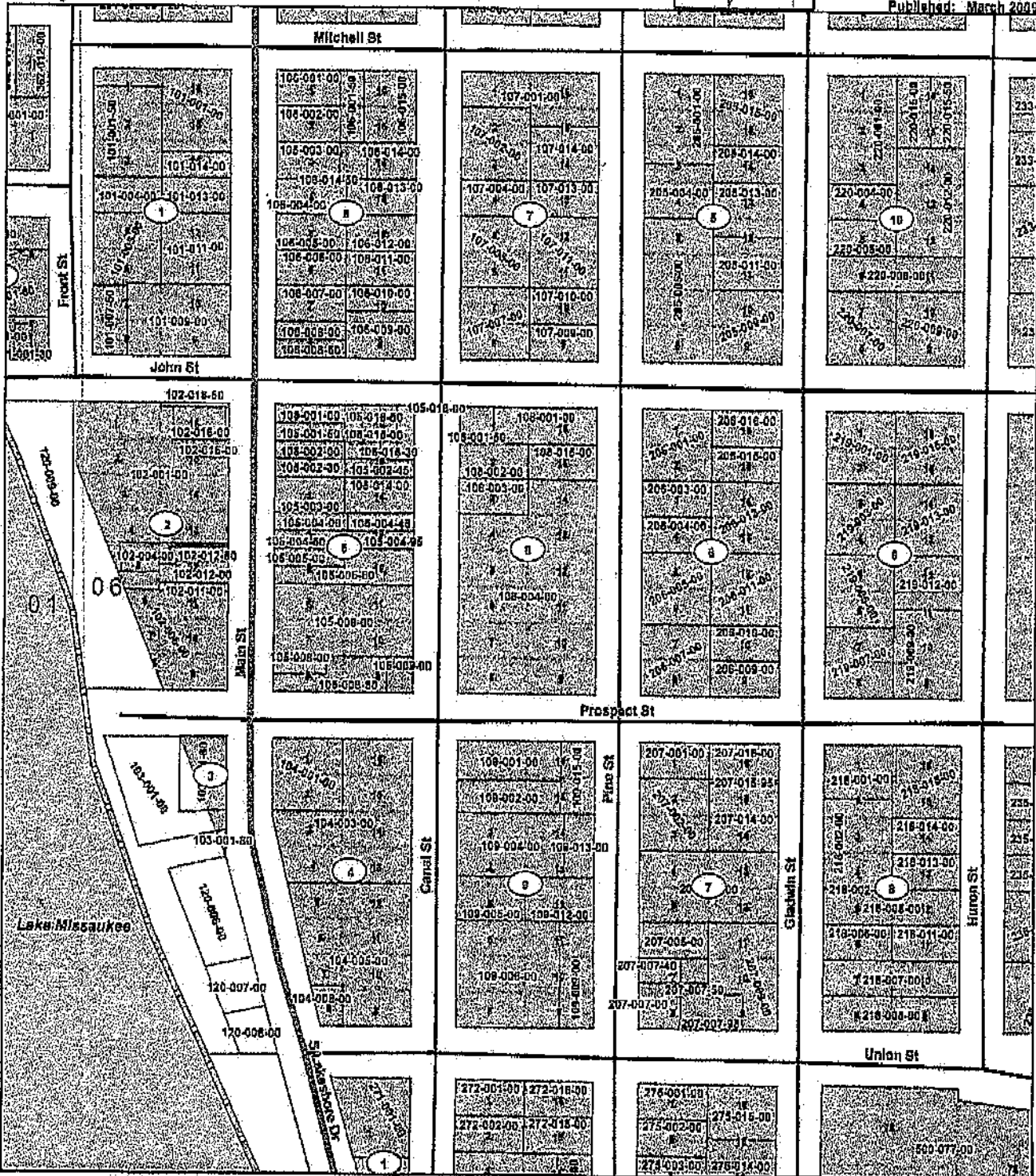
